PRESENTATIONS

<u>Update on the Southern California Wildfires – Chief Garrett Veyna</u>

Much of the San Luis Unit has been sent to Southern California – 15 engines, 12 crews, 2 dozers and 2 damage assessment team members. The staffing levels have reached 15,000 with crews from Mexico and other States joining forces. With more Santa Ana winds expected, crews will be prepositioned in efforts to quickly catch new starts.

<u>Insurance Update – Stacy Korsgaden</u>

The Sustainable Insurance Strategy completed its analysis on schedule of December 31, 2024. Things may change now with multiple devastating fires with huge losses in Southern California. It's estimated that the average house in Pacific Palisades is worth \$3.4 million and a potential loss of \$30 billion.

The Strategy was aimed to stop a total market crisis, improve access to insurance and address the ongoing threat of climate change. The long-term goal of the Sustainable Insurance Strategy is more affordable and accessible home insurance policies for Californians — but that can only happen if there are more insurance companies willing to write policies in the state. A few things need to happen first. Part of the strategy includes changing how insurerers calculate rates. With catastrophe modeling, insurance companies could use predictive algorithms, new scientific research, historical data and computer simulations to better approximate the financial implications of a catastrophic disaster and price insurance rates accordingly. Pre-Sustainable Insurance Strategy, insurance companies could only use historical data when setting home and wildfire insurance rates.

Cal Poly WUI Faculty Student Collaboration Facility – Margot McDonald

The facility is designed to encourage collaboration and further aligns the university's mission of student success with workforce and innovation needs. It will further enable, encourage and facilitate innovation in an interdisciplinary environment that brings together students, faculty and strategic partners.

<u>Cal Poly Earn by Doing Program – Tim Northrup</u>

The Earn by Doing Internship Program is an opportunity for students to gain paid work experience at one or more of the college's departments. The program allows students to work part-time, up to 20 hours per week, gaining technical and leadership skills in positions related to their chosen careers. The program is being offered for the WUI Fire Institute and will fit well in the new collaboration facility.  - \$1.5 Billion approved for wildfire programs
 - Most funds are earmarked for agency programs
 - o 2025 State Coastal Conservancy has opened applications
 - o 2025 USDA Community Wildfire Defense Grants
 - Application period closes February 28, 2025
 - CWPP development can be awarded up to \$250,000 with 10% match required
 - Projects in existing CWPP can be awarded up to \$10 million with 25% match required
