### **PRESENTATIONS/DISCUSSIONS**

#### **North Coast SLO-RESIL Project Specific Analysis**

North Coastal San Luis Obispo County Regional Ecological Strategy for Improving Landscapes (SLO-RESIL). The proposed project consists of vegetation treatments on up to 88,151 acres of USLTRCD's jurisdictional boundary within the California Coastal Zone, from the northern San Luis Obispo County line to Toro Creek near Morro Bay. The project area encompasses both private and public lands, excluding federally managed lands and existing, previously approved CalVTP projects within its bounds (i.e., Hearst Ranch Forest Health Fuels Reduction Project, Covell Ranch Forest Health Fuels Reduction Project, and Cambria Reserves Restoration and Vegetation Treatment Project). An objective of the proposed project is to expand on and increase the efficacy of ecologically restorative forest health projects previously approved by the California Coastal Commission and successfully implemented under the existing USLTRCD Forest Health and Fire Resilience PWP. The proposed treatment types are fuel break and ecological restoration. The proposed treatment activities consist of mechanical treatments, manual treatments, prescribed burning, herbicide application, and prescribed herbivory.

#### **Cal Poly Unmanned Aerial Vehicles-Lidar**

The Geospatial Systems Lab at Cal Poly, launched by Professor Marc Horney, whose research is focused on rangeland ecology and management, uses LiDAR (light detection and ranging) technology to scan complex, living landscapes and render them into virtual three-dimensional representations of themselves. Currently, the lab team is focusing on fire-prone ecosystems along the Central Coast. Research areas include fire and fuels behavior, ecosystem composition, landscape-level biomass estimation, watershed management and multi-temporal terrain modeling. This technique can cover 300-

500 acres per day. The research opportunities are endless; they can identify which plants are alive and healthy (doing photosynthesis) and which ones are dead or dying and drying out. It gives the physical dimensions of vegetation canopies on the land surface below — how tall, how continuous, how dense all valuable metrics to firefighters. This system offers advances in fire ecology and mitigation and management.

### **SLO County Weed Abatement Ordinance Proposal**

This item is scheduled to be presented at the July 8 Board of Supervisor meeting with the hearing scheduled for August 14, 2025. No changes have been made to the proposed ordinance since it was presented to SLO FSC in March. With SLO County facing a huge budget shortfall, changes are expected and will be presented to SLO FSC once available.

- Paso Robles Focus Group – 1,400 goats in riverbed, \$75,000 to replant and increase canopy in riverbed, City experiencing best weed abatement compliance this year, June 7 Safety Fest, July 4 Barney Schwartz Park fireworks
- Avila Valley Focus Group – Chipping in See Canyon, HOAs achieved FireWise status, Texiera Ranch will have remote mastication work done
- Atascadero Focus Group – Going to council on May 27 for FSHZ adoption, Oak Ridge Estates has applied for FireWise status (800 acres, 54 dwelling units), 10 miles of roadway clearance, shaded fuel break work scheduled

## **NEW GRANT OPPORTUNITIES**

- 2025 PG&E Fuel Reduction Grants
  - 3 proposals submitted – No projects were selected for funding
    - PG&E has \$3 million in funding and received \$11 million in requests
- 2024 Proposition 4 – Safe drinking water, wildfire prevention, drought preparedness and clean air bond act of 2024
  - \$1.5 Billion approved for wildfire programs, some of which will be for new grant funding
  - Most funds are earmarked for agency programs
- 2025 State Coastal Conservancy has opened applications
- County Coordinator Funding
  - Awarded \$150,080 to reinstate funding through July 2026
