## **PRESENTATIONS**

### Templeton Feed and Grain Fire

The fire which was ruled as arson started late July 4<sup>th</sup>. According to surveillance video obtained from a nearby business you can see an illegal firework being thrown at the building and land on the roof exploding. Cameras inside the business show a rain of sparks and fire break out instantly in the storage area of the bagged feed and grain. The fire burned for days, severely damaging the facility and leading to the demolition of its two silos. Although townspeople were asked to conserve water during suppression efforts, water was never an issue. An early estimate of water used to fight the fire is 2.1 million gallons. Cooperative agencies were instrumental in getting this fire under control and out. A thank you dinner was held recognizing all agencies involved and the community's gratitude for the efforts.

The bills deal with discounts, reducing red tape, grants, home hardening, catastrophe bonds and non-renewal protections.
SLO County Parks - Building Industry -	Thank you for the firefighting efforts keeping Lopez Lake and Biddle Park safe New fire code goes into effect January 1, 2026, a lot of focus on home hardening
Cal Poly - Cambria - Toro Creek -	There is a new grant opportunity for wildfire curriculum Pinedorado was a huge success, 750 Fisci books were distributed Property with hoarding, fire safety concerns has not progressed with County Code Enforcement

**FIRE SAFE COUNCIL BUSINESS**

- UC Cooperative Extension representative, Bill Tietje, has retired. Lillian Thaoxaochay has been recommended to replace Mr. Tietje. Royce Larsen has been designated as the alternate.

- Scholarships/Local Grants
  - Cal Poly Tech Park building is ready for occupancy. The WUI Fire Institute has received their furniture, courtesy of a SLO FSC local grant. The SLO FSC office is ready to occupy. Ribbon cutting ceremony has been postponed.
  - Allan Hancock College Fire Academy students will be presented with information about our scholarship program on September 19.
- Focus Groups / Fire Wise Communities  
Pismo Beach and West Nipomo are continuing efforts to organize. Squire Canyon, Bragg Canyon, and Thousand Hills areas want to work together developing an evacuation plan.
- Mid-State Fair  
The event was deemed a success. PG&E joined the education center space for a few days promoting "Right Tree Right Place" and found it productive. They would like to join our efforts again next year.
- Policy 017 – SLO FSC Executive Director Responsibilities  
Policy written to document the Executive Director has the authority to make purchases on behalf of the SLO FSC. This action was done at the request of CAL FIRE Southern Region Grants.

- Chipper Day Scheduling Software  
The program is working well. One hundred seventy-five (175) residences have signed up for the program since implementation with 252 cubic yards removed.
- Website and IT Projects  
Things with Scout, Ladris and Fireshed are moving forward with 546 evacuation zones in SLO County. The projects are all about sharing information with the public and first responders.
- CEQA Suspensions, Exemptions and NOE Reversals  
Implementation period has been extended from 2 years to 5 years.

SLO FSC has had five (5) CNRA CEQA suspensions approved:

1. Hearst Pico Creek
2. Covell Ranch
3. Stagecoach Project (Stagecoach and Parkhill Roads)
4. Heritage Ranch (Water treatment plant and Lake Naci resort entrance)
5. Chispa Project (Blue Sky Ranch, Highway 229 and Rocky Canyon area)

Upper Salinas Las Tablas RCD has had three (3) CNRA CEQA suspensions approved:

1. Strawberry Canyon
2. Leffingwell Ranch
3. Krazzinski Ranch

SLO FSC has submitted three (3) more projects for suspension consideration:

1. Coyote Project – O'Donovan Road and Highway 58
2. Pressley Project – Parkhill and Huer Huero Road
3. Atascadero Creek – City of Atascadero

## **GRANT / PROJECT ACTIVITY UPDATES**

- Pico Creek Project – Hearst Ranch  
This project is a 232-acre mastication project. An electronic meeting and vote were held by the Executive Committee on August 25, 2025, due to the time constraints with executing the contract and starting the project before the next regularly scheduled Board of Directors meeting. Eight (8) bid proposals were received and reviewed. The contractors associated with those bids were interviewed to establish their knowledge of the scope of work. It was deemed that North Coast Tree Service was the most qualified for award. The Executive Committee directed the Executive Director, Dan Turner, to complete and execute contract documents with North Coast Tree Service for the amount of \$819,700 to complete the 232-acre Hearst Pico Creek mastication project.  
**It was moved, seconded and approved to affirm the Executive Committee's interim action to complete and execute the project contract with North Coast Tree Service for the amount of \$819,700 as presented: Pierson Second: Slate**
- PG&E Grant Offer  
PG&E has offered a grant, asking us to serve as fiscal sponsor for SLO County Fire, for the purchase of a portable fire suppression tank system (\$40,000). Due to time constraints, SLO FSC being the fiscal sponsor is faster than having SLO County Fire go through the steps to accept the grant themselves. As sponsor, SLO FSC agrees to accept the grant, purchase the system and have it delivered to SLO County Fire.

**It was moved, seconded and approved to accept the grant from PG&E and purchase the portable water tank system for donation to SLO County Fire as presented: Jones Second: Cosgrove**

## **FUTURE GRANT OPPORTUNITIES**

- 2024 Proposition 4
  - Governor signed early funding release of \$130 million to Department of Conservation
  - Coastal Conservancy \$30 million
- 2025-26 CAL FIRE CCI
  - Application closed August 6
  - \$950,000 cap per application, multiple applications from organization allowed
  - Proposition 4 can only be used for Hazardous Fuel Reduction projects
  - CA CCI can be used for Hazardous Fuel Reduction, Public Education and Planning projects
  - SLO FSC submitted four applications:
    1. Countywide Planning \$936,000
    2. South County Projects \$932,000
    3. North County Projects \$941,400
    4. USFS-Los Padres Projects \$835,970

## **GOOD OF THE ORDER**

State Coastal Conservancy / Department of Conservation had a meeting September 16, 2025. The \$4.5 million in grant funding will be broken into block grants. More information to follow as it becomes available.
