



LETTER OF COMMITMENT

Participation in Fuel Reduction Projects

1. COMMITMENT

I give my commitment to participate with the San Luis Obispo County Fire Safe Council (a nonprofit organization) in the Fuel Reduction Project outlined below. I will participate freely in the project. I consent to fuels reduction work being undertaken on my land.

2. MUTUAL HOLD HARMLESS AND INSURANCE

As the landowner, I will hold harmless the San Luis Obispo County Fire Safe Council and any other entity involved in this project in connection with any loss, liability, or injury to persons or property that arises from performance of work under this agreement.

The San Luis Obispo County Fire Safe Council will hold harmless the landowner in connection with any loss, liability, or injury to persons or property that arises from performance of work under this agreement.

Work crews will have liability insurance provided by the contractor or the San Luis Obispo County Fire Safe Council for work on the landowner's property.

3. TERM AND ACCESS

Within the dates specified, the San Luis Obispo County Fire Safe Council shall give the landowner reasonable actual notice at least two weeks in advance, and any necessary arrangements will be made prior to each requested access. Reasonable and actual notice may be given by mail, in person, or by telephone. This agreement may be amended only by prior written notification of either party executing this agreement.
